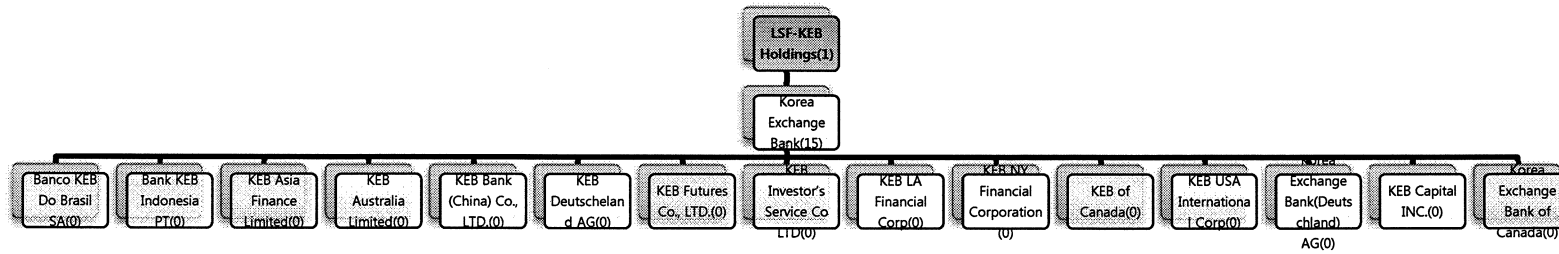

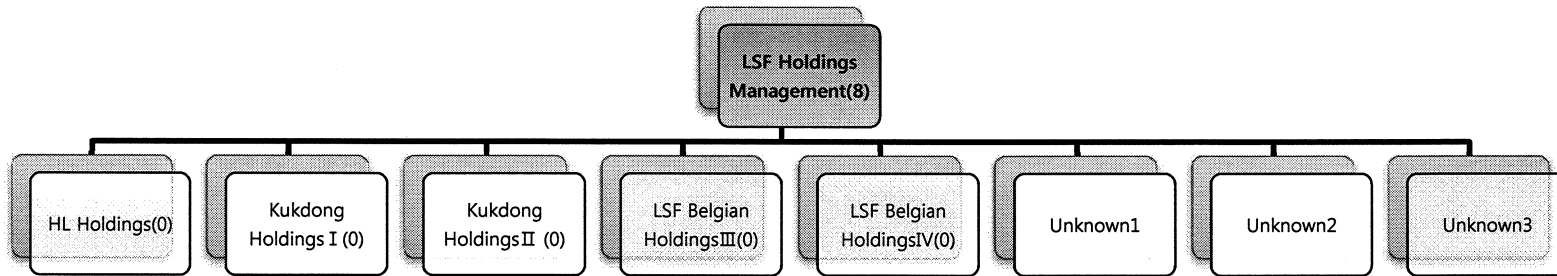
3-1-2. Lone Star Investment Management 지배구조도
